## **COVID-19 Disclaimer**

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and those with underlying medical conditions are especially vulnerable. By visiting CCSM, you voluntarily assume all risks related to exposure to COVID-19.

Acknowledgement and Assumption of Risks Associated with Exposure to Covid-19:

COVID-19 is a highly infectious, life-threatening disease declared by the World Health Organization to be a global pandemic. COVID-19 is associated with a serious and potentially deadly condition called Multisystem Inflammatory Syndrome in Children (MIS-C). CCSM has implemented safety rules and precautions in order to mitigate the spread of COVID-19. However, those measures do not completely protect against the spread of COVID-19. By choosing to visit CCSM in person, you acknowledge that even if Student and family follow all directions, instructions, and rules and exercise utmost personal care, there will remain a certain irreducible inherent risk to Student, and those you associate with, and you accept that risk. You voluntarily assume the risk that you or Student may be exposed to or infected by COVID-19 by entering CCSM's campus and that such exposure or infection may result in personal injury, serious illness, permanent disability, and/or even death. You further acknowledge that children who become infected with COVID-19 may later develop MIS-C and you assume this risk. You voluntarily permit Student to attend CCSM in person and assume full responsibility for Student those you associate with for any and all risks of illness, injury, disability or death associated with exposure to COVID-19.

Release of Liability for Covid-Related Claims Including Ordinary Negligence & Covenant Not to Sue:

To the fullest extent permitted by law, you absolve, release, and waive any potential claims against the Released Parties for any claims for personal injury, disability, illness, damage or death from exposure to COVID-19, whether such exposure occurs during or after your or Student's attendance at CCSM's campus or CCSM events, except for claims arising from the gross negligence or intentional misconduct of CCSM.
