

# Hours & Fees:

Minimum rental time is 4 hours.

The fee for a 4-hour period is \$400 plus a \$100 security deposit. Hourly rate after initial 4-hour period is \$100 per hour. Credit cards are accepted. (Please note there is a 3% transaction fee for credit card payments.) For payment by check, please make your check payable to CCSM.

The security deposit of \$100 is required and refundable after the event upon approval by the Executive Director or Business Manager, and providing the items mentioned below (#1-3) have been met.

### Both the fee and a \$100 security deposit are due at the time of inquiry to confirm your reservation of the Recital Hall.

#### Insurance:

A Certificate of Liability Insurance is required for all dates of use with \$1 million occurrence and \$2 million aggregate. The Certificate of Liability Insurance can be obtained via a company of your choice, or from The Event Helper, Inc. at: <a href="https://www.theeventhelper.com/">https://www.theeventhelper.com/</a>. Please contact them directly for any questions: (855) 493-8368. A copy of the Certificate of Liability Insurance must be provided to CCSM prior to dates reserved.

### Cancellations:

Cancellation will be subject to forfeit as follows:

- Cancellation on the day of the event will be subject to forfeit of 100% of rental fee.
- Cancellation requests made less than one month prior to the date of the event will be subject to a \$25 booking fee.

### **Requirements:**

- 1) No food, gum or drinks are allowed in the Recital Hall.
- 2) Maximum audience capacity is 75. No additional chairs (seats) can be added. Aisles and exit rows cannot be blocked.
- 3) Following use of the Recital Hall:
  - Chairs and equipment must be replaced in original positions (per posted diagram)
  - All trash must be picked up and placed in trash cans
  - All lights must be turned off
  - The A/C-Heat must be turned off
  - All entrance doors must be locked
